Old Business:

CONSTRUCTION BOARD OF APPEALS

AMBULANCE CONTRACT

Mark Wilk was present to present the Board with the final ambulance agreements. The current agreement needs to be terminated before the signing of the new agreement. Motion made by Campbell, supported by Massey, to approve the Agreement to Terminate Ambulance Management Contract with Cheboygan Life Support Systems, Inc. Motion carried. Motion made by Oja, supported by McKenzie to approve the Interlocal Agreement Among the City of St. Ignace, the Township of Moran, the Township of St. Ignace, the Township of Brevort, the Township of Trout Lake and the Township of Hendricks, with St. Ignace Township contributing 17% of the funding. Motion carried.

ZONING ADMINISTRATOR

Clerk Oja presented a letter of resignation from the Township Zoning Administrator, Matt Oja. Mr. Oja is resigning as of May 1, 2020, and will continue to perform his duties until that date. A notice will be put in the local paper advertising for the position. Motion made by Campbell, supported by Massey, to accept the resignation of Matt Oja as the Zoning Administrator. Motion carried.
