Old Business:

**Straits Area Fire Authority**

Moran Township Supervisor, Susan Dionne, was present to explain the SAFA request for additional funds for operating expenses. Straits Area Fire Authority (SAFA) expenses are currently paid by the City of St. Ignace and taken from the 206 Fire Fund. Said fund is monies deposited yearly for Equipment Reserve. Instead of the expenses being taken from the 206 Fire Fund, the Authority would prefer they be taken from the City of St. Ignace's General Fund and included in the annual operating expenses for the fire department. The amount can then be split between the three (3) units based on the fire agreement. This action requires the township boards and city council to approve the addition of the SAFA expenses.

Motion by Mitchell, supported by Danielson, to approve the request to have the expenses for the Straits Area Fire Authority be reported with the annual operating expenses of the fire department and included as part of the Fire Agreement. Motion passed.
