**New Business:**

***Road Match Agreement***

The 2023 Road Agreements suggested by the Mackinac County Road Commission were discussed. The four projects suggested were brushing on Ingalsbe Road, Charles Moran Road and Belonga Road and South Jamison Road clearing & grubbing, machine grading, 100 cy of 22A gravel from 1640 feet south of St. Ignace Road southerly 3000 feet.

Motion made by Massey, supported by Danielson, to approve the four Road Match Agreements with the Mackinac County Road Commission for 2023. Motion carried.

**Correspondence:**

Supervisor Danielson met with 906 Lawn & Landscaping at the township cemeteries to review the cleanup work that needs to be done prior to the new fencing being installed. Mr. Molina will submit an estimate to the township on both the cleanup and new fencing. Clerk Oja suggested new signs at the cemeteries, as there are none now. The Board agreed. Clerk Oja will look into the signs.

Treasurer Massey asked about the township newsletter for 2023. The Board will work on putting one together. Future updates and news may be just posted on the website instead of sending a newsletter, depending on the news that needs to be provided to the residents.
