

NOTICE OF ORDINANCE ADOPTION
ST. IGNACE TOWNSHIP, MACKINAC COUNTY, MI
Ordinance No. 45

**Ordinance Addressing Floodplain Management Provisions of the
State Construction Code**

An ordinance to designate an enforcing agency to discharge the responsibility of the Township of St. Ignace located in Mackinac County, and to designate regulated flood hazard areas under the provisions of the State Construction Code Act, Act No. 230 of the Public Acts of 1972, as amended.

The Township of St. Ignace ordains:

Section 1. AGENCY DESIGNATED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, the Michigan Bureau of Construction Codes is hereby designated as the enforcing agency to discharge the responsibility of the Township of St. Ignace under Act 230, of the Public Acts of 1972, as amended, State of Michigan. Michigan Bureau of Construction Codes assumes responsibility for the administration and enforcement of said Act throughout the corporate limits of the community adopting this ordinance.

Section 2. CODE APPENDIX ENFORCED. Pursuant to the provisions of the state construction code, in accordance with Section 8b(6) of Act 230, of the Public Acts of 1972, as amended, Appendix G of the Michigan Building Code shall be enforced by the enforcing agency within the jurisdiction of the community adopting this ordinance.

Section 3. DESIGNATION OF REGULATED FLOOD PRONE HAZARD AREAS. The Federal Emergency Management Agency (FEMA) Flood Insurance Study (FIS) Entitled “Flood Insurance Study for Mackinac County, all jurisdictions, effective December 15, 2022” and the Flood Insurance Rate Map(s) (FIRMS) panels included on index panels 26097CIND1A, 26097CIND2A, effective December 15, 2022 are adopted by reference for the purposes of administration of the Michigan Construction Code, and declared to be a part of Section 1612.3 of the Michigan Building Code, and to provide the content of the “Flood Hazards” section of Table R301.2(1) of the Michigan Residential Code.

Section 4. REPEALS. All ordinances inconsistent with the provisions of this ordinance are hereby repealed.

Section 5. PUBLICATION. This ordinance shall be effective after legal publication and in accordance with the provisions of the Act governing same.
