

**TOWNSHIP OF ST. IGNACE  
COUNTY OF MACKINAC, STATE OF MICHIGAN**

**AMENDED ORDINANCE NO. 42**

**BUILDING CODE**

An ordinance repealing and replacing Ordinance No. 42 in its entirety (St. Ignace Township Ordinance Book No. 42).

**The Township Board of St. Ignace Township, Mackinac County, Michigan, Ordains:**

An ordinance for the designation of a building discipline as the enforcing agency of the Michigan Building Code, Michigan Residential Code, Michigan Rehabilitative Code, and Michigan Uniform Energy Code, for St. Ignace Township, Mackinac County, Michigan.

**SECTION I: Title.**

This ordinance shall be known and cited as the St. Ignace Township Building Code Ordinance.

**SECTION II: Adoption.**

Pursuant to section 8b(6) of the Still-Derossett-Hale State Construction Code Act, Act 230 of 1972, the Township of St. Ignace hereby adopts and enforces the following agencies and codes:

Pursuant to the provisions of the Michigan Building Code, in accordance with Section 8b(6) of 1972 PA 230, MCL 125.1508b(6), the building official of the Township is designated as the enforcing agency to discharge the responsibility of the Township under 1972 PA 230, as amended, State of Michigan. The Township of St. Ignace assumes responsibility for the administration and enforcement and adopts by reference the Michigan Building Code 2015, as amended, throughout their corporate limits. A copy of the 2015 Michigan Building Code shall be on file.

Pursuant to the provisions of the Michigan Residential Code, in accordance with Section 8b(6) of 1972 PA 230, MCL 125.1508b(6), the building official of the Township is designated as the enforcing agency to discharge the responsibility of the Township under 1972 PA 230, as amended, State of Michigan. The Township of St. Ignace adopts and assumes responsibility for the administration and enforcement of the 2015 Edition of the Michigan Residential Code, which incorporated the 2015 Edition of the International Residential Code for one and two-family dwellings. A copy of the 2015 Michigan Residential Code shall be on file.

The Township of St. Ignace adopts and assumes responsibility for the administration and enforcement of the 2015 Edition of the Michigan Rehabilitation Code for Existing Buildings, which incorporated the 2015 Edition of the International Rehabilitation Code for Existing

Buildings. A copy of the 2015 Michigan Residential Code for Existing Buildings shall be on file.

The Township of St. Ignace adopts and assumes responsibility for the administration and enforcement of the 2015 Edition of the Michigan Uniform Energy Code, which incorporated the 2015 International Energy Conservation Code. A copy of the 2015 Michigan Uniform Energy Code shall be on file.

### **SECTION III: Fees.**

All fees will be established, from time to time, by resolution through the board of the Township. In compliance with Act 230 of 1972, Section 22, the building department shall collect the fees established under this subsection. In compliance with Act 230 of 1972, Section 22, the Township board shall only use fees generated under this section for the operation of the enforcing agency or the construction board of appeals, or both, and shall not use the fees for any other purpose.
