Clerk Oja presented the Resolution No. 2026-02 General Appropriations Act. Motion by Goudreau, supported by Frazier, to approve the General Appropriations Act. Roll call vote: Yes – Danielson, Goudreau, Oja, Frazier No – None, Absent - Mitchell. Motion carried.
